

Eurotech: Giampietro Tecchiolli, Executive Vice President and Chief Technology Officer, resigns from all his offices.

Since 2008 he had been the Executive Vice President of Eurotech S.p.A..

Giampietro Tecchiolli holds as of today 0.54% of the share capital of Eurotech S.p.A..

Marco Carrer, currently Vice President of Software Engineering, succeeds to Tecchiolli in the role of Chief Technology Officer of Eurotech Group. Marco Carrer has a Master in Computer Science from Cornell University and a Degree in Electronic Engineering from the University of Padua. Carrer has been working in Eurotech Group since 2011, taking care of the direction and coordination of the software development activities, with particular reference to M2M/IoT platforms. Prior to joining Eurotech, Carrer worked for 13 years at Oracle in the United States, following a distinguished career and reaching the role of Senior Director of Software Development.
