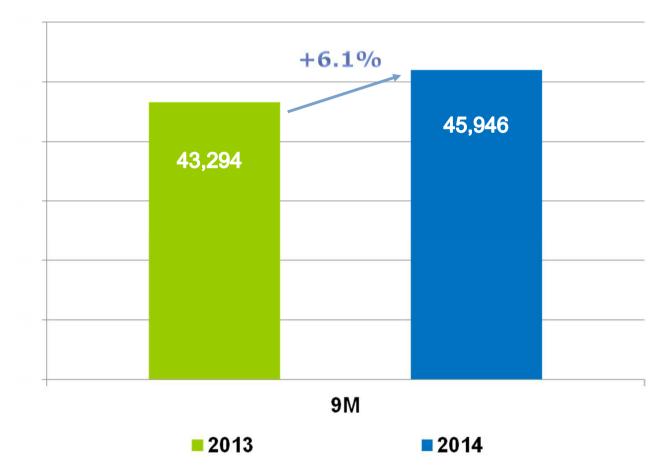

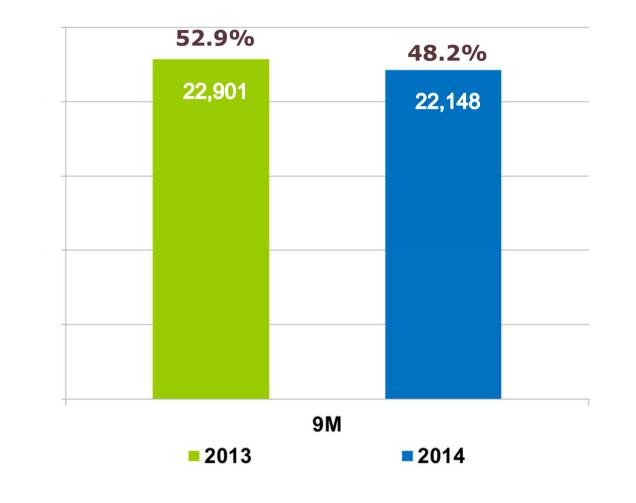
REVENUES

GROSS PROFIT MARGIN

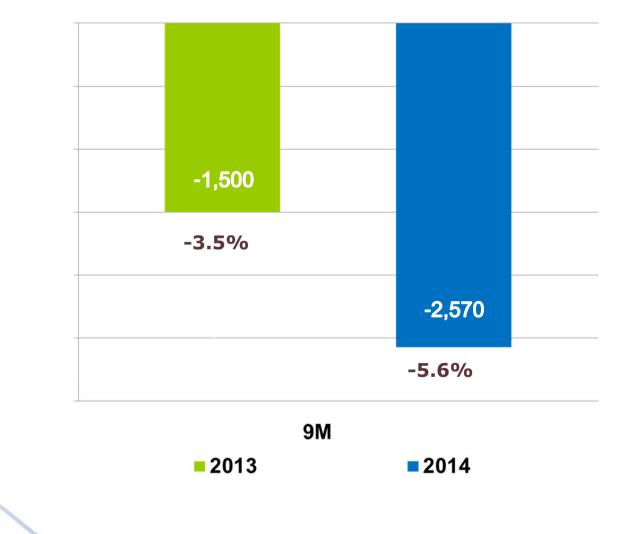

EBITDA

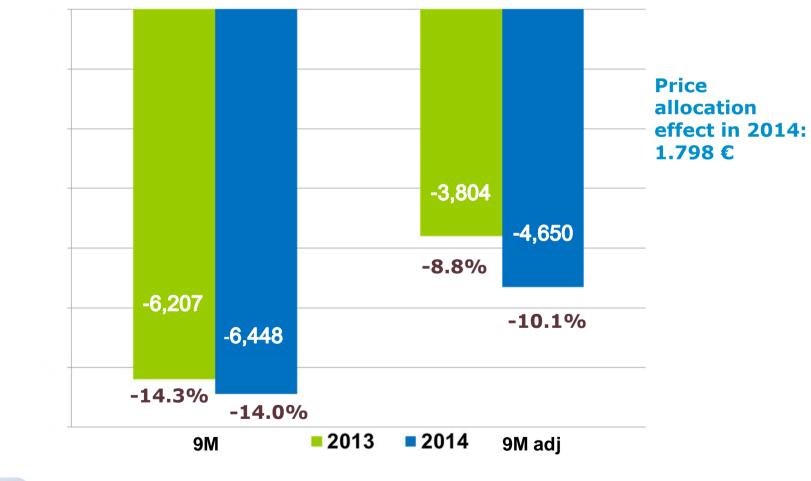

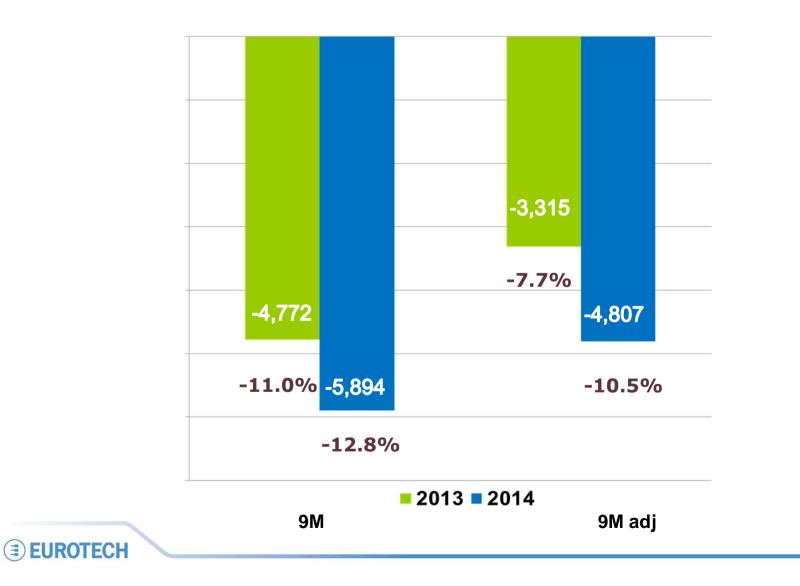

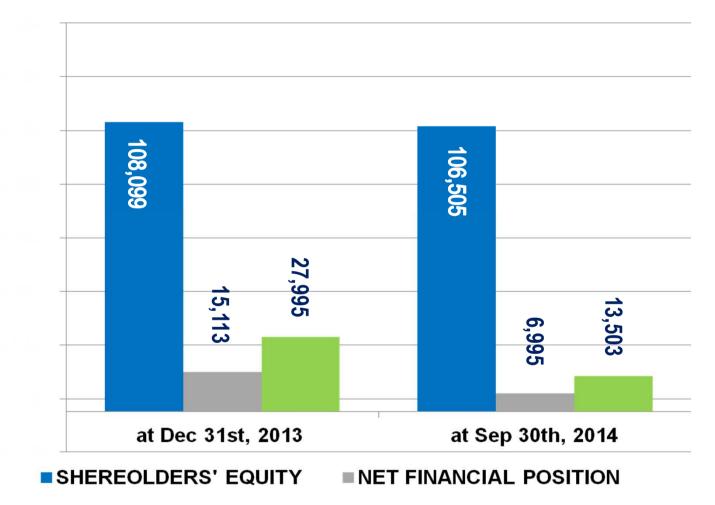
Group's net results & Group's net results adj, 30 September 2013-2014 (€/000)

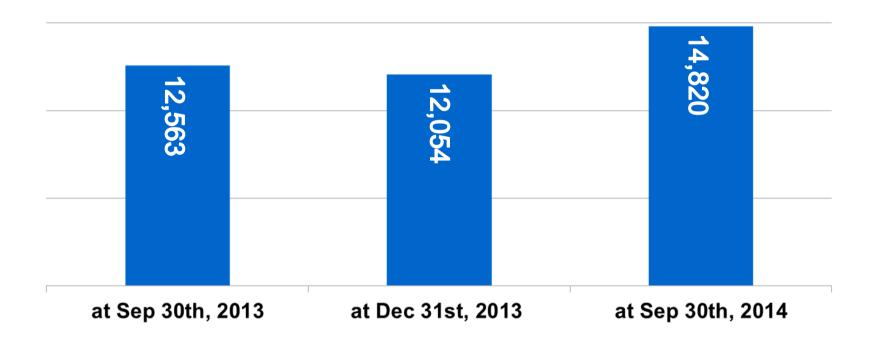
31 December 2013 and 30 September 2014 (€/000)

30 September 2013, 31 December 2013 and 30 September 2014 (€/000)

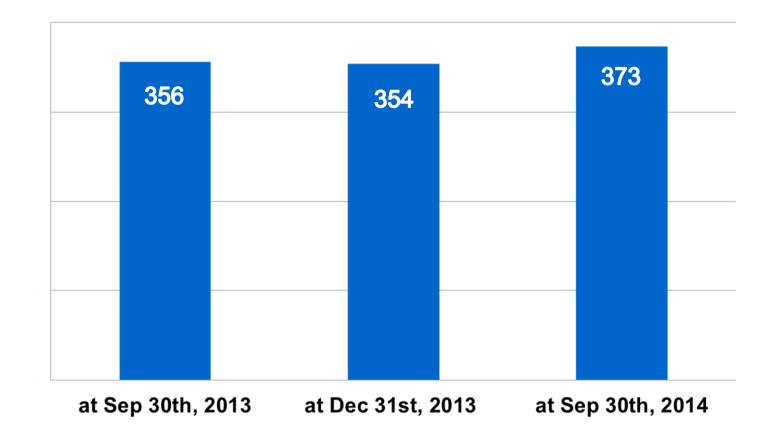
